No motion or second were given as the opening roll call is not commonly a resolution.

2021-207 RESOLUTION APPROVING THE BOARD MINUTES FROM THE REGULAR MEETING HELD ON SEPTEMBER 13, 2021.

Ms. Murphy moved to adopt resolution 2021-207. Ms. Drummond seconded the motion. Ms. Bryant abstained. Ms. Drummond voted yes. Ms. Gannon voted yes. Mr. Harrison abstained. Ms. Murphy voted yes. The resolution passed by a vote of 3-0.

At this time, Mr. Steve Easterling, Superintendent, updated the Board on the following items: Lawrence County schools Spring 2021 test data, middle school/high school end-of-school-day crosswalk/traffic control by the Village of Coal Grove Police Department on Marion Pike, new outside waterline connections at the middle school/high school buildings by the Village of Coal Grove, elementary playground progress, and various service contracts with the Lawrence County Educational Service Center for the 2021-2022 fiscal year.

RESOLUTION TO ENTER INTO AN AGREEMENT WITH THE LAWRENCE COUNTY EDUCATIONAL SERVICE CENTER (LCESC) FOR THE 2021-2022 SCHOOL YEAR TO PROVIDE SPEECH SERVICES, CURRICULUM SUPERVISORS, AND TO COLLABORATIVELY PROVIDE SERVICES TO STUDENTS IDENTIFIED WITH DISABILITIES. THE TOTAL ESTIMATED COST FOR FY21 IS \$200,509.50. A COPY OF SAID AGREEMENT SHALL REMAIN ON FILE IN THE OFFICE OF THE TREASURER.

RESOLUTION ALSO ENTERS INTO AN AGREEMENT WITH THE LCESC TO PROVIDE A TRUANCY OFFICER RETROACTIVE TO AUGUST 1, 2021. THIS AGREEMENT SHALL RENEW UNLESS TERMINATED BY EITHER PARTY IN WRITING PRIOR TO MARCH 1<sup>ST</sup> OF THE YEAR OF TERMINATION. THE TOTAL ESTIMATED COST FOR FY21 IS \$12,693.03. AN EXECUTED COPY OF SAID AGREEMENT SHALL REMAIN ON FILE IN THE OFFICE OF THE TREASURER.

RESOLUTION ALSO ENTERS INTO AN AGREEMENT WITH THE LCESC FOR THE 2021-2022 SCHOOL YEAR TO PROVIDE ALTERNATIVE SCHOOL SERVICES AT A TOTAL COST OF \$14,062.33. A SIGNED COPY OF SAID AGREEMENT SHALL REMAIN ON FILE IN THE OFFICE OF THE TREASURER.

Mr. Harrison moved to adopt resolution 2021-208. Ms. Drummond seconded the motion. All members voted yes.

At this time, Mr. Bradley Miller, Treasurer, updated the Board on the disposal of district-owned personal property, a recent donation to the high school prom, and the district's checking account with Citizens Deposit Bank changing to Peoples Bank as of the close of business on September 17, 2021. Peoples Bank bought out Citizens Deposit Bank.

## **RATIONALE:**

- 1. THE BOARD OWNS VARIOUS PIECES OF PLAYGROUND EQUIPMENT, A MAINTENANCE TRAILER, AND AN IP PHONE SYSTEM, WHICH ARE NO LONGER NEEDED FOR SCHOOL PURPOSES, AND SOME OF WHICH ARE UNSAFE AND NO LONGER FIT FOR USE AND MUST BE DISPOSED OF ("PERSONAL PROPERTY").
- 2. THE BOARD IS AUTHORIZED TO DISPOSE OF THE PERSONAL PROPERTY PURSUANT TO SECTIONS 3313.17 AND 3313.41 OF THE OHIO REVISED CODE, AS WELL AS SECTION 7300 OF THE CURRENT BOARD POLICY MANUAL. THE PERSONAL PROPERTY DOES NOT EXCEED \$10,000 IN VALUE.

## THE BOARD OF EDUCATION RESOLVES AS FOLLOWS:

- 1. THE BOARD DETERMINES THAT THE PERSONAL PROPERTY IS VALUED AT LESS THAN \$10,000 AND IS NO LONGER NEEDED FOR SCHOOL PURPOSES. THE BOARD ALSO DETERMINES THIS ACTION TO BE IN THE PUBLIC INTEREST AND BENEFIT OF THE SCHOOL DISTRICT. ANY ITEMS DETERMINED BY THE SUPERINTENDENT TO BE UNSAFE OR UNUSABLE MAY BE DISPOSED OF.
